**VI. PUBLIC FORUM**

**Andrew Bermudez** stated that the Town had just come through a tumultuous time and that the system worked as it went the way the citizens wanted. He feels like he doesn't want to go through this again and it shouldn't be taken lightly. It is a small Town and things like this are never good. With that being said, he would like to begin a discussion to close some loopholes in terminology. Being able to run and being eligible to run are two different things. He feels that our Charter should match the school's policies, such as, you aren't eligible to run if you don't meet the qualifications. **Mr. Bermudez** stated that he isn't against homeschooling but would also like to see something stating that if you are the facilitator of a home school co-op that you can't be on the School Board. He sees it as a conflict of interest as it would be the same as having a principal of a private school sitting on the board of a public school. He is okay with getting shut down but would like to have a civil discussion on the matter as it isn't fine for anyone

to not be able to share their opinion. He would also like to look through the charter for other loopholes that can cause a disturbance.

**Frank Spizuoco** thanked the council for putting money into paving at the beach. He is very pleased with the results and the water drainage issues seem to have been fixed. He stated that summer camp will be happening again along with swimming lessons. The Council needs to think about how the beach will be maintained and sustained in the future, as all the improvements and programs have been achieved through fundraising.
